The **Communication Ethics Division** invites submissions of scholarly research for presentation at NCA's 104<sup>th</sup> **Annual Convention in Salt Lake City, Utah, November 8-11, 2018**. We promote research and teaching related to ethical issues in all aspects of human communication and encourage educational programs that examine communication ethics. Our members come from across the discipline and have a wide variety of methodological perspectives. We believe that in an age of diversity and difference communication ethics plays a significant role in our professional and civic lives.

This year's theme, "Communication at Play," invites us to consider the role of play in our research, teaching, and service. Examples of such work might include papers, panel discussions, or performances that address one of the following areas:

- 1). Scholars, activists, and practitioners in the field of communication ethics who employ creativity and innovation to help diverse community groups solve problems, move beyond impasses, and advance our knowledge of the communication discipline.
- 2). Play in terms of cultural reification and subversion. This year's theme provides an opportunity for critical reflection on those who are left out of the game. We consider scholarship and civic action that explore how communication ethics constructively engages communities that historically have been silenced.
- 3). Engagement and curiosity in our pedagogy. Research documents the value of play in teaching at the college level to increase student involvement, learning, and empathy. Play and improvisation are also proven training techniques that can lead to creative solutions and deepen our understanding of communication ethics.
- 4). Interdisciplinary inquiries and discovery of how communication ethics is "at play" or in the midst of civic action.
- 5). Play, wellbeing, and care for the Other. Through the activity of play, one engages, learns, and finds enjoyment. Research demonstrates how play increases wellbeing and helps people manage the stresses of everyday life. As we consider the wellbeing of Others, what are the possibilities of play and communication ethics? How do we care for the Other and respond well? Focusing on the wellbeing of the Other will provide new insights in communication ethics and care.

We welcome submissions for individual papers and paper sessions centered on communication ethics and the possibilities of play for various outlets of communication scholarship including panel discussions, performances, and films. Submissions that include local activists and practitioners and/or creative formats (e.g. poetry, debate, discussion) are especially encouraged. We also welcome the opportunity for co-sponsored panels (e.g., Interpersonal Communication Division and Communication Ethics Division) as we look to expand the collective range and inclusivity of communication ethics. Given the prominence of ethics in the NCA mission and the NCA Credo for Ethical Communication, we believe that communication ethics is a highly important connection that runs through our diverse and rich field. All submissions must be made via NCA Convention Central and are due **March 28, 2018**. For a definition of submission types, please refer to the step-by-step “How to Submit” instructions provided in the Convention Resource Library (<http://www.natcom.org/conventionresources/>).

**1. Individual Paper Requirements:** These papers are stand-alone and are not associated with any other paper sessions or panel discussions. Please complete the required electronic submission fields including title, description, author(s), and keywords. Please indicate if your submission is a student paper on the electronic submission form. Paper submissions must include no more than a 30-page (excluding references), double-spaced uploaded copy of the paper. On your title page, please indicate what outside sources (if any) are funding your research. Copies must be uploaded to NCA Convention Central and must NOT include identifying information. Instructions on how to prepare an unidentifiable copy are provided in the Convention Resource Library (<http://www.natcom.org/conventionresources/>). Papers that contain identifying information will be returned to the author for proper preparation. Based on the results of the peer reviews, the Division’s 2018 convention planner will use the individual papers to create a few paper sessions, including the top paper panel. Scholar-to-Scholar (S2S) is typically presented in a poster format. If your work lends itself better to visual presentation, one-on-one discussion, or you are looking for personal feedback on your ideas, check the Scholar-to-Scholar (S2S) agreement box in NCA Convention Central. At the convention, division/caucus leaders, journal editors and other experts, known as Wandering Scholars, will circulate at S2S and interact with participants and their work, seeking to

energize, enhance, and expand collective thinking as they make connections with your presented work.

**2. Paper Session Requirements:** This session is composed of approximately 3-5 papers presented together, based on a particular theme. Paper sessions are evaluated as a whole. A respondent for these sessions is highly recommended while a chair is required. Submissions must include:

- a) a session title
- b) an overall session description
- c) the name of the session’s chair (chair may also be a session author)
- d) the name of the session’s respondent (if you have one)
- e) a title, description (no more than 75 words) for each individual paper, and author’s information
- f) a rationale for the session (no more than 250 words), outlining the importance of the submission as it relates to the convention theme and communication ethics research

**3. Panel Discussion Requirements:** This type of session is a group of approximately 3-6 people, creating a theme around which to discuss their particular ideas and/or expertise regarding communication ethics. Papers are *not* presented during a panel discussion. Submissions must include:

- a) a panel title
- b) a general description of the panel discussion topic (no more than 75 words)
- c) the name of the session’s chair (chair may also be a panel presenter)
- d) the name for each individual on the panel
- e) a rationale for the panel discussion’s importance as it relates to the convention theme and communication ethics interests (no more than 250 words)

**4. Performance Session Requirements:** This session is composed of a single or multiple performances based on a particular theme. Performance sessions are evaluated as a whole. A respondent for these sessions is highly recommended and a chair is required. Submissions must include:

- a) a session title
- b) an overall session description
- c) the name of the session's chair (chair may also be a session performer)
- d) the name of the session's respondent (if you have one)
- e) a title, description (no more than 75 words) for each individual performance, and performer's information
- f) a rationale for the session (no more than 250 words), outlining the importance of the submission as it relates to the convention theme and communication ethics research
- g) the length of the performance

**5. Film Submission Requirements:** Please complete the required electronic submission fields including title, description, film maker(s), and keywords. Completed films, scripts, and outlines on in-the-works projects will be considered. Submitters should include a Word document with the running time of the film (if completed) and a URL to view the film online as their supporting file. DO NOT upload your completed film as a supporting file.

Please note audio-visual or other special requests where indicated for all submission types.

The Communication Ethics Division recognizes excellence in communication ethics scholarship with an annual award for top conference papers. Based on reviewers' responses, a top papers panel will be created by the Division's convention planner. A top paper by a scholar(s) and a top paper by a graduate or

undergraduate student will be presented. The top paper by a scholar(s) will receive a certificate of achievement, and the top student paper will receive a small cash award and certificate during the panel presentation. Both recipients are recognized during our business meeting.

All submitters are encouraged to review the Professional Standards for Convention Participants, located in the Convention Resource Library, prior to submission. Helpful resources, including live and recorded step-by-step instructions on how to submit, are also available in the Convention Resource Library (<http://www.natcom.org/conventionresources/>).

- II. Approval of Minutes - Amanda G. McKendree, Chair

- III. Treasury Report - Amanda G. McKendree, Chair (on behalf of Gina Ercolini)
  - A. On August 31, 2017 we renewed our non-profit status with the Colorado Secretary of State.
  - B. We have \$380 in our budget.
    1. \$240 is used to cover the cost of plaques
    2. \$100 is given to the top graduate student paper winner
    3. The remainder is used for printing costs.
- IV. Program Planner's Report - John Prellwitz, Vice Chair/Program Planner
  - A. John Prellwitz thanked all reviewers and acknowledged the top reviewers.

26 Individual papers were submitted and 11 were accepted  
6 panels were submitted and 2 were accepted  
13 paper sessions were submitted and 5 were accepted  
Total submissions: 45  
Total accepted: 18 (40% acceptance rate)  
  
5 paper sessions were co-sponsored with the Philosophy of Communication Division. 1 session was co-sponsored with each of the following: Disability Issues Caucus, Asian/Pacific American Caucus, Japan-U.S. Communication Association, and the Political Communication Division.
- V. 2018 Program Planner- Michelle Leavitt, Vice Chair elect
  - A. The 104<sup>th</sup> annual convention will be held in Salt Lake City. NCA has reserved a variety of hotels to accommodate members' different budgetary needs. Sessions will be held at the John W. Gallivan Center and Hilton Salt Lake City Center.
  - B. The theme for next year's convention is "Communication at Play."
    1. Star Muir, NCA Second Vice President, chose this theme because it is "imaginative, strategic, and creative." We can think about the theme in terms of being "at play" or in the middle of the action.

2. The Communication Ethics Division has been given 10 slots. We were encouraged to take advantage of this opportunity to submit our research.

C. There was discussion on capping the page length of submissions and whether submissions are required to be single spaced.

VI. Communication Director's Report- Amanda G. McKendree, Chair (on behalf of Sean Swenson, Communication Director)

- A. Sean was unable to attend the business meeting.
- B. One newsletter was circulated this past year.
- C. We need to fulfill the role of Communication Director.

VII. Ad-hoc Committee Updates, Amanda G. McKendree, Chair

- A. *Ethica: Special Issue*-edited by Bert Ballard and Melinda Farrington
  1. Bert reported that the special edition went out in March 2017 and he thanked the nine contributors.
  2. Melissa Cook asked how it was distributed. Bert said it was sent to the Communication Ethics Division list serve and posted on CRTNET.
- B. Communication Ethics Pre-Conference- Mridula Mascarenhas and Karen Lollar
  1. Karen did a lot of work on pre-planning but it was not accepted.
  2. Amanda asked about using the content as a possible book project.
- C. Communication Ethics Resolution - Paula Tompkins and Mark Beekman  
Paula and Mark submitted the resolution to the Resolutions Committee, but it was rejected due to overlap with the NCA Credo for Ethical Communication. Amanda will

represent Paula and Mark at Legislative Assembly on 11/18/17. Amanda asked if we should resubmit the resolution next year.

- D. Ken Chase asked about the review of the credo at Legislative Assembly. LeeAnne Bell McManus provided a summary of the discussion of how all credos were reviewed by the Resolutions Committee, but nothing was changed.

VIII. Elections - LeeAnne M. Bell McManus, Immediate Past Chair

- A. LeeAnne announced that we need to elect a Communication Director since Sean has stepped down.
  1. LeeAnne reviewed the responsibilities of the Communication Director. The primary responsibility is to edit *Ethica*, and to disseminate information on our website (commethics.org) and Facebook page.
  2. Discussion followed and Amanda recommended the Communication Director streamline channels of communication. Tammy Swenson Lepper offered to help with our Division's Facebook page.
  3. Ron Arnett – nominated Matt Mancino for Communication Director  
Vote: Unanimously approved
  4. Paul Turpin retires next year and will hand off his responsibility for the Communication Ethics Division's web page on NCA's website. At our next convention we will discuss Paul's responsibilities and replacement.
  5. Melba Vélez Ortiz asked about the yahoo group for Communication Ethics and discussion followed on the

- Communication Director checking the email list. LeeAnne said we could crosscheck with NCA's list. Amanda said the most recent list has 220 members down from 240 members.
- B. We need to elect a Program Planner to plan the 2019 Baltimore convention. Janie Harden Fritz was nominated and the vote to elect her was unanimous.
- C. Next year we will need to fill the secretary role.
- IX. Legislative Assembly Report - Amanda G. McKendree and LeeAnne McManus Bell
- A. LeeAnne summarized LA and said discussion focused on the topic of resolutions and the language of the resolutions. She said wordsmithing was difficult with 120 people. Janie Harden Fritz framed the discussion as "meaning smithing."
- B. Amanda gave an update on how NCA is trying to make the annual convention more academic. They received feedback that it is not as rigorous as ICA and RCA.
- C. Amanda announced a writing retreat for midcareer faculty. Details will be posted on CRTNET.
- X. Awards Committee Report- LeeAnne M. Bell McManus, Immediate Past Chair  
LeeAnne thanked the committee members: Lori Charon, Melissa Cook, Pat Gehrke, Spoma Jovanovic, and announced the award winners:

- XI. NCA Updates - Justin Danowski, Governance Manager, NCA  
Justin said he will be the point of contact for all questions about NCA and he provided the following reminders:

- B. NCA has a new website
- C. Executive Committee will open all online resources to the general public in January 2018. Taylor Francis journals, Spectra, and the member directory will remain password protected.
- XII. David McMahan, candidate for NCA Second Vice President  
David McMahan shared his goals and vision to support scholars from all academic levels (high school, community college, bachelors, masters, and doctoral programs); to connect areas of scholarship; and to promote diversity and inclusivity. He said his candidate statement will be available on the NCA website.
- XIII. Other business  
Michelle Leavitt, Vice Chair elect, proposed the idea of creating a new role for a graduate student to represent the Communication Ethics Division to other graduate students.  
-Amanda suggested the graduate student could attend next year's interest group session.  
-Melba and LeeAnne acknowledged that the future of our Division depends on our ability to attract young scholars.  
-Ken asked if we have interest and Adam Goldsmith, graduate student at the University of Maine, expressed interest.  
-Melissa acknowledged that the *Ethica* editor has a vote, but she recommended this position not be a voting officer. She recommended we create an ad hoc committee.  
-Ron said the Vice Chair could put together a committee and decide whether or not to continue next year.



-Leeanne clarified that we do not need to vote on this proposal as the Vice Chair can create the committee.

-Ken affirmed that the Vice Chair takes initiative to create the committee.

The 15th National Communication Ethics Conference will be held June 6–8, 2018 (Wednesday through Friday), at the Duquesne University Power Center in Pittsburgh, PA—sponsored by the Department of Communication & Rhetorical Studies and the Communication Ethics Institute.

The theme for this year's conference centers on Communication Ethics in an Age of Dispute with keynote speakers addressing four content areas:

- (1) *Communication Ethics and Argument*,
- (2) *Communication Ethics and Semiotics*,
- (3) *Communication Ethics and  
Communities of Practice*, and
- (4) *Communication Ethics and Crisis*

Papers: We invite abstracts of 200–500 words or completed papers of a maximum of 30 pages, including references. Submissions should be double-spaced, using MLA, APA, or Chicago citation styles.

Panel Proposals: Panel proposals may include up to five participants. Please include a title page with a 500-word (maximum) rationale and a 200-word abstract for each presentation.
